Blackmore is a small village, its possition is very isolated with narrow country roads.

The bus service is very limitted and The only shop is a small co-op which already can't cope, parking is a nightmare. Not long ago our post office was relocated into the co-op giving a very unsatisfactory service. The just isn't enough room to support such a service. The one school is already full and the near by doctors surgery is severely overstetched I here are more suitable locations within Brentwood Barough Council which are not green bett more substanable and have better access to urban developement. Therefore the proposed plan does not conceder the limits of Blackmorer infrastructure and The stress such peopo developements would place on it Such a documented historical village attracts many visitors, bukers; cyclest and horse viders. This would all change if Blackmores numbers increase so dramitically as it would be fare too dangerous as Flooding is already a problem, I fear this would only get werse
