AND the Trustees to the intent and so as to bird (so far as practicable) the land hereby transferred into whosesoever hands the same may come and to benefit and protect the adjacent or neighbouring lands of the said Percy Alfred Bayman forming part of the Kiddleton Hall Estate now being developed as a building estate but so as not to be personally liable for any breach of this covenant occurring after they have parted with the land hereby transferred hereby covenant with the said Percy Alfred Bayman that the erection of the Hospital which the Trustees are to build upon the land hereby transferred shall not be commenced until a plan thereof shall have been submitted to the said Percy Alfred Bayman and approved by him so far as regards the elovation on the North East and West sides and that the Trustaes and the persons deriving title under them will not erect any part of the said Hospital and will not at any time hereafter . subsequently extend the same nearer to Crescent Drive than Thirty feet from the back of the path on the South side thereof and will not at any time hersafter erect or permit to be eroctod any building or wall on the land hereby transferred except the said Hospital or any extension thereof including Furses Homes Entrance Lodges or any buildings used in connection with the said Hospital

aND the said Percy Alfred Bayman hereby covenants with the Trustees

- 1. To p y all tithes and land tax (if any) in respect of the land hereby transferred and to keep the Trustees indemnified therefrom
- 2. TO erect wrought iron gates and railings at both entrances to Crescent Drive at the points marked "C" and "D" on the said plan
- 5. TO complete the said road known as Crescent Drive with foot path to conform with the rural aspect of the district.
- 4. TO plant the boundary so as to enclose the land hereby transferred with white thorm or other suitable shrubs or hedge
- 5. In the event of the said Percy Alfred Enyman dying within twelve months from the date hereof without having effectively devised the said land hereby transferred to the Trustees upon the Trusts and subject to the powers aforesaid and the Transfer hereby made becoming void to reimburse to the Trustees all moneys expended by them on the said land hereby transferred or otherwise in connection with the premises and to keep the Trustees effectively indemnified against any loss whatever occasioned thereby.

AND we the said Percy Alfred Bayman and the Trustees hereby apply to the Augistrar to enter notice of the covenants hereinbefore contained on the Register

If is hereby agreed that the power of appointing new Trustees of these presents shall be vested in the same persons as are from time to time entitled to appoint new Trustees of the said Trust Deed of the 28th day of Eay 1895 under the provisions thereof


