We support the Main Modifications to policy R09 (Land off Warley Hill, Warley) set out under MM92. They clarify the policy expectations for the development of the site.

Within MM92, we note the stipulation at 3a of the policy, which requires "off-site highways infrastructure improvements as may be reasonably required by National Highways and Essex County Council in accordance with policies MG05 and BE08 (the planning obligations will determine the level and timing of payments for these purposes)", and "quietway' cycle routes connecting transfer hubs to schools in Brentwood Town Centre." These appear to accord with the Infrastructure Delivery Plan Part B Update (document reference F70) which specifies the requirements and the allocations to which they relate, including the policy R09 site. In this respect we support any relevant planning obligations associated with the development of the site where they meet the tests set out in Regulation 122 of the Community Infrastructure Levy Regulations 2010, namely that they are:

- a) necessary to make the development acceptable in planning terms;
- b) directly related to the development; and
- c) fairly and reasonably related in scale and kind to the development.

We also note the Appendix 1 Housing Trajectory (MM114) which identifies a delivery timetable between years 2022/3 and 2023/4, which we agree with.

Additional references within the MM text to the need for "high quality design" and for development to sustain and enhance nearby Listed heritage assets are also noted.
