

Comments

I do not support the housing development proposal for Plot 143 (Land East of Peartree Lane and North of Peartree Close). This would remove some of the green belt land around our area, which in addition to the other proposed green belt developments in Doddinghurst erode the character of the village. The addition of 50 houses in a quiet rural residential street would unreasonably increase road traffic and noise/light pollution in the surrounding area. I consider that the report promoting development on the plot is misleading, prejudiced and unrepresentative of the opinion of existing residents.
